**TOURIST TAX – INFORMATION FOR GUESTS**

The tourist tax was established by the Municipality of Salsomaggiore Terme pursuant to the Municipal Council's decision No. 10 of 25/02/2015. It will come into force on April 1, 2015.

**What is the tax for?**

The tax will be used to fund tourism activities, including those supporting accommodation facilities, maintenance, use and restoration of cultural and environmental assets, as well as local public services.

**Who pays the tax?**

Non-resident visitors over the age of 12 years, spending one or more nights in local accommodation facilities. Payment is made to the manager of the facility, who issues a receipt therefor. People omitting the payment will incur sanctions established under the National Law.

**How much is the tax?**

The tax is payable per person, per night, up to seven consecutive nights, even in more accommodation facilities.

**Who is tax – exempt?**

- persons under 12 years of age;
- persons under 16 years of age, belonging to sporting groups that attend competitions and events with the sponsorship of the municipal administration;
- accompanying persons of patients undergoing therapies and medical examinations in healthcare establishments within the municipal territory or in Vaio Hospital;
- parents or carers assisting minors of 18 years of age or handicapped patients admitted to health facilities in the Municipality or in "Vaio" Hospital (maximum two per patient);
- staff of national armed forces, provincial and local police forces, as well as the staff of fire national department and civil protection staying in one of accommodation facilities for working reasons and not for
- persons staying in the Municipality in order to offer voluntary services in the city for special or emergency events or following measures adopted by the public authorities for humanitarian relief purposes;
- persons who are staying due to displacement in the wake of natural disasters;
- persons staying for reasons of study, enrolled at any Upper Middle School, legally acknowledged in the Municipality of Salsomaggiore Terme;
- Bus drivers and tour leaders offering assistance to organized groups;
- the staff and collaborators of the accommodation facility itself;
- guests staying for free in the accommodation facility for promotional purposes.
